ARTICLE I

NAME AND ADDRESS

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member of the Company, or upon the occurrence of any other event that terminates the continued membership of a Member in the Company, the remaining Member or Members shall have the right to continue the business of the Company in accordance with the terms and conditions of the Company's Operating Agreement.
