### ARTICLES OF ORGANIZATION

### FOR

### FOREX CAPITAL ADVANTAGE, LLC

The undersigned hereby execute and acknowledge the following Articles of Organization for the purpose of forming a limited liability company under the laws of the State of Florida.

### ARTICLE I. NAME OF LLC

The name of the limited liability company is FOREX CAPITAL ADVANTAGE, LLC.

The address of the principal office of this limited liability company shall be Suite 6-H, 1501 South Flagler Drive, West Palm Beach, FL 33401 and the mailing address of the limited liability company shall be the same.

### ARTICLE II. NATURE OF BUSINESS

- (1) Any breach of his or her duty of loyalty to the company, or to its members;
