## Articles of Organization of Smart Vacations, L.C.

The undersigned hereby execute and acknowledge the following Articles of Organization for the purpose of forming a Florida limited liability company under the Florida Limited Liability Company Act (Florida Statutes, Chapter 608).

### Article I - Name

The name of the limited liability company is Smart Vacations, L.C.

### Article II - Address

### Article III - Duration

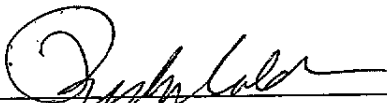
