## ARTICLES OF ORGANIZATION

## OF

## **DEEP WOODS, LLC**

1. <u>Name</u>. The name of this limited liability company is DEERWOODS, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
