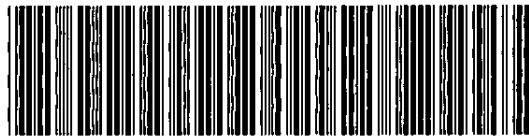

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, provides the following information for the purpose of amending the Articles of Organization of **AQUARIAN DEVELOPMENT, LLC**, which was formed under the laws of the State of Florida pursuant to Articles of Organization originally filed with the Department of State on August 23, 2002, and assigned document number L02000021730.

1. Article I of the Articles of Organization is amended to read:

**ARTICLE I
