ARTICLES OF ORGANIZATION OF RBH FARMS, L.L.C.

The undersigned, being authorized to execute and file these Articles, hereby certifies that

ARTICLE I - Name:

ARTICLE V - Admission of Additional Members:

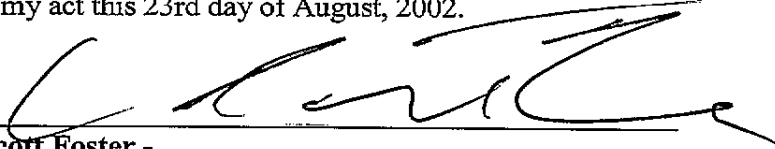
New members of the Limited Liability Company shall be admitted only upon the consent of all the members or otherwise pursuant to the terms and provisions of its regulations.
