ARTICLES OF ORGANIZATION

FOR

MEDLINE MANAGEMENT, LLC

ARTICLE I - NAME

The name of the Limited Liability Company is: MEDLINE MANAGEMENT, LLC

ARTICLE II - ADDRESS
