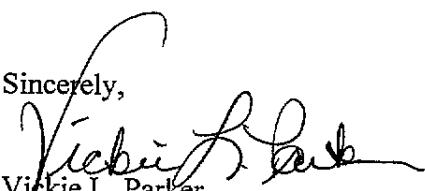

**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be CENTRAL FLORIDA RESEARCH GROUP, LLC ("Company").

ARTICLE II

Address. The mailing address and street address of the principal office of the Company shall be 1132 Symonds Avenue, Winter Park, FL 32789.

ARTICLE III
