ARTICLES OF ORGANIZATION

OF

BURNSTEIN & BURNSTEIN L. L. C.

1. NAME. The name of this limited liability company is set forth above.

2. PURPOSE AND POWERS. This company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to Florida law. The company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to Florida law as the same may be amended from time to time.

4. DURATION. The company's existence shall commence on the filing of these articles with the Secretary of State of Florida and shall continue until dissolved.

7. CAPITAL CONTRIBUTIONS, PROFIT AND LOSS ALLOCATION AND MEMBER VOTING.

A. The initial amount of cash or property to be initially contributed by each of the members of the company is as follows: Joseph Dima, \$225.00

B. The company's profits and losses shall be allocated among the members in accordance with the regulations of the company.

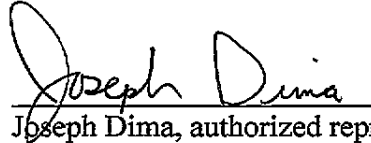
C. All members of the company shall be entitled to vote on matters relating to the company. Each member's vote shall be weighted in accordance with the regulations of the company.

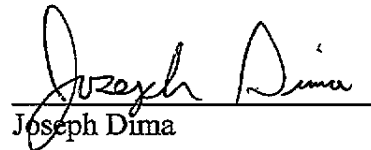
