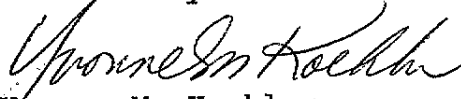

ARTICLES OF ORGANIZATION
FOR
ANGLE IN MOBILE COURT, LLC

ARTICLE I - NAME

The name of this limited liability company shall be **ANGLE IN MOBILE COURT, LLC.**

ARTICLE II - DURATION

This limited liability company shall have perpetual existence.

ARTICLE III - PURPOSE

Except as restricted by these Articles of Organization, this limited liability company is organized to own and operate a mobile home park and for each and every legal and lawful purpose for which a limited liability company may be organized pursuant to the Florida Limited Liability Company Act.

ARTICLE IV - PRINCIPAL OFFICE

ARTICLE V - INITIAL REGISTERED AGENT AND OFFICE

ARTICLE IX - MEMBERS' RIGHTS TO CONTINUE BUSINESS

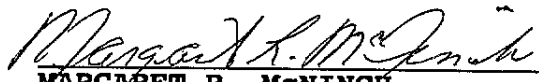

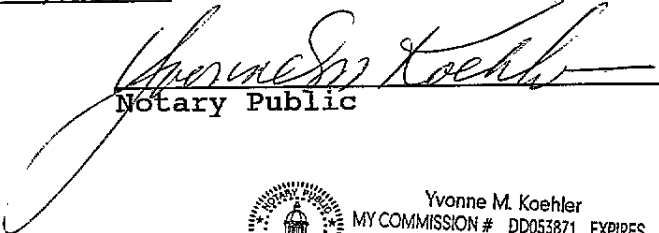
