**Article I - Name**

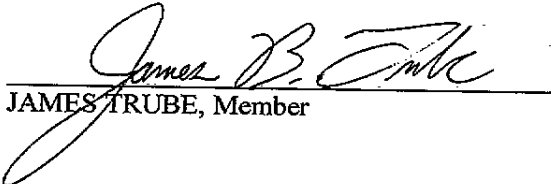
**Article VIII - Limitation on Agency Authorized of Members**

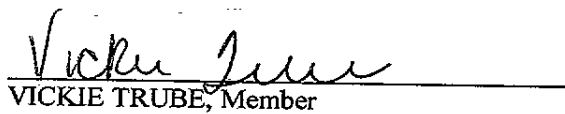

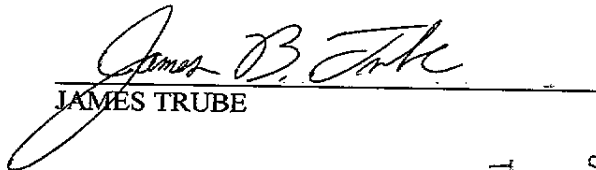
