ARTICLES OF ORGANIZATION OF  
SCHMICE, LLC  
A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name

The name of the limited liability company (hereinafter referred to as the "Company") is "SCHMICE, LLC."

ARTICLE II - Address

The mailing address and street address of the principal office of the Company is 9 N.E. First Avenue, Ocala, Florida 34470.

ARTICLE III - Duration

The period of duration for the Company shall be perpetual.

ARTICLE IV - DESIGNATION OF REGISTERED AGENT

The Company is to be managed by the members.


ARTICLE VI - Limitation on Agency Authority of Members
