

Article 1. The name of the limited liability company is 929 Alton Road, L.L.C. (the "Limited Liability Company").


Article 2. The date of the filing of the Articles of Organization of the Limited Liability Company was August 28, 2002.

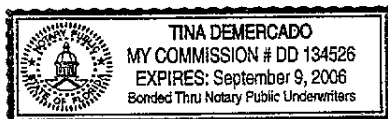


