**ARTICLES OF ORGANIZATION  
OF  
APPLIED INVESTMENTS – JACKSONVILLE BEACH, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608, or other applicable provision).

**ARTICLE I - Name**

The name of this Limited Liability Company is: Applied Investments – Jacksonville Beach, LLC (the "Company").

**ARTICLE II - Duration**

The Company shall exist from the date of filing these Articles with the Florida Secretary of State until terminated in accordance with the Company's regulations and/or in accordance with law.

**ARTICLE III - Address**

The mailing and street address for the principal office of the Company is Applied Investments – Jacksonville Beach, LLC, 2770 N.W. 43rd Street, Suite B, Gainesville, FL 32606-7419.

**ARTICLE IV - Admission of Additional Members**

Additional members to the Company may be admitted, but only if all the current Members unanimously agree to the admission of the additional members and unanimously agree to the terms of admission. Members can only be removed if all the current Members unanimously agree.

**ARTICLE V - Members Rights to Continue Business**

If a Member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a Member in the Company, the remaining Members may, by unanimous written

agreement, continue the business of the Company.

#### **ARTICLE VI - Management**

The daily, usual course of business of the Company will be managed by a manager (the "Manager"). Upon due authorization by the Members, the Manager can contract with the necessary professionals or service providers such that the daily business of the Company can be performed, subject to the controls as set forth herein and as set forth in the regulations. The Manager shall be elected annually by the Members in the manner prescribed by and provided for by the Members of the Company. The Manager shall hold the office(s) and have the responsibilities accorded to him/her by the Members. The Members reserve the general management of the Company to themselves, and therefore all decisions outside the usual course of the Company's business will require a vote of the Members holding two-thirds interest in the Company. The name and address of the Manager who is to serve until the first annual meeting or until his successor is otherwise selected is as follows:

#### **ARTICLE VII - Operating Agreement**

The Members shall have the power to adopt, alter, amend, or repeal operating agreements of the Company containing provisions for the regulation and management of the affairs of the Company.

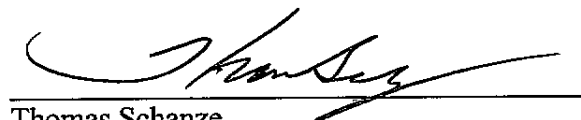

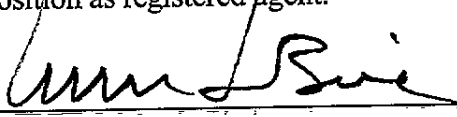
