# ARTICLES OF ORGANIZATION AQUA GUARD PLUS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization. FILED WO.56

### ARTICLE I - NAME

The name of the limited liability company shall be AQUA GUARD PLUS, LLC.
