

The undersigned hereby makes, subscribes, acknowledges, and files these Articles of Organization for the purpose of forming a professional limited liability company under the Laws of the State of Florida.

ARTICLE I
NAME

ARTICLE II
DURATION

This professional limited liability company shall exist in perpetuity.

ARTICLE III


