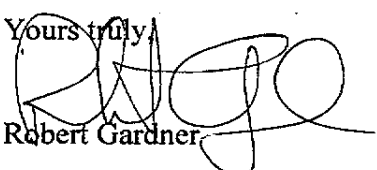

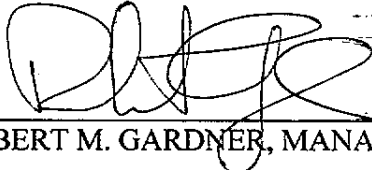
SECOND: The Articles were filed with the Florida Department of State on SEPTEMBER 3, 2002.
