# ARTICLES OF ORGANIZATION OF R&H 34th Street, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, at Chapter 608, Florida statutes, hereby makes, acknowledges, and files, the following Articles of Organization.

### ARTICLE I -- NAME

The name of the limited liability company shall be R&H 34th Street, LLC ("Company").

### ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Limited Liability Company is 4840 Ridgemoore Boulevard, Palm Harbor, Florida 34685.

### ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles of organization.

# ARTICLE IV -- REGISTERED OFFICE AND AGENT

### ARTICLE V -- ADMISSION OF NEW MEMBERS

A member may transfer his or her interest in the company as set forth in the operating agreement of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the other members of the company

other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

## ARTICLE VI -- MANAGEMENT

The company shall be managed by the members in accordance with the operating agreement adopted by the members for the management of the business and affairs of the company. The operating agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
