LIMITED POWER OF ATTORNEY

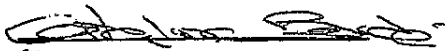

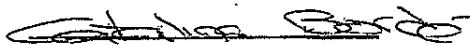

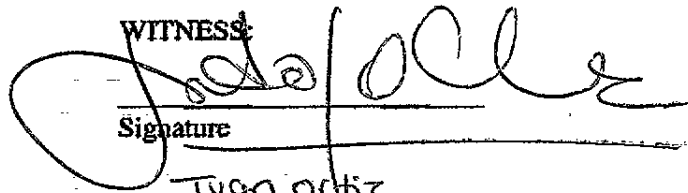
