

The undersigned, acting as an authorized representative of the initial members of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, *Florida Statutes*, adopts the following Articles of Organization:

ARTICLE I

Name

The name of this limited liability company is PRESGAR IMAGING OF NEW JERSEY, L.L.C. (the "Company") and its principal office and mailing address is 14055 Riveredge Drive, Suite 350, Tampa, Florida 33637.

ARTICLE II

Effective Date

The Company shall commence its existence upon the filing of these Articles of Organization with the Florida Secretary of State.

ARTICLE III

Purpose of Organization

The Company is organized to enable its members to transact any lawful business for which a limited liability company may be organized under Florida law.

ARTICLE IV

Initial Registered Office and Agent

The street address of the initial registered office of the Company shall be 14055 Riveredge Drive, Suite 350, Tampa, Florida 33637, and the initial registered agent of the Company at such address is Jeffrey P. Greenberg.

ARTICLE V

Management of the Company




