**ARTICLES OF ORGANIZATION**  
**for**

**A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I – NAME**

The name of the limited liability company shall be **APPLEGATE DEVELOPMENT, L.L.C.**, (the “company”).

**ARTICLE II - ADDRESS**




