**ARTICLES OF ORGANIZATION OF
FALCON FLIGHT CENTER, LLC**

Article I

The name of the limited liability company ("Company") is FALCON FLIGHT CENTER, LLC.

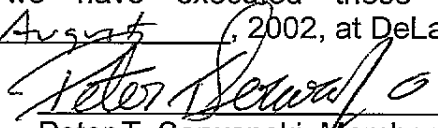
Article VII
