ARTICLES OF ORGANIZATION PF CONSIGNMENT ENTERPRISES, L.L.C.

And the state of t The undersigned, for the purpose of forming a limited liability company under the Florida Limite. Liability Company Act, F.S. Chapter 608, hereby makes and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be PF Consignment Enterprises, L.L.C. ("Company").

ARTICLE II - PURPOSE AND POWER

The purpose for which the Company is organized is to lease, own, operate and manage property, real, personal and mixed, of any kind and nature, to conduct a retail and/or consignment clothing business, and to otherwise conduct any lawful business to promote any lawful purpose, and to engage in any lawful act or activity, for which limited liability companies may be organized under the laws of the State of Florida, including, but not limited to, the purchase, development, sale, service, lease, and management of personal and real properties of all kinds and descriptions.
