Articles of Organization Of Grove Optical, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

Article 1 - Name

The Company of the limited liability company shall be Grove Optical, L.L.C., ("Company").

<u>Article 2 – Address</u>

The principal place of business of the Company in Florida shall be 2380 S.W. 28th Street, Miami, Florida 33133 and the mailing address shall be the same.
