The name of the limited liability company shall be BROAD SOLUTIONS, LLC, ("company").



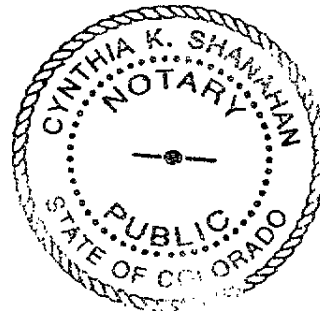


