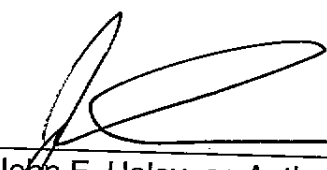
**ARTICLE VI

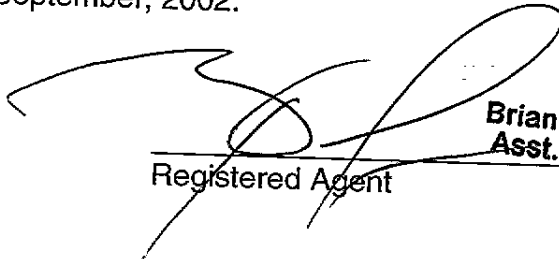
