#### ARTICLES OF ORGANIZATION

OF

#### COUCH'S PAINTING OF CENTRAL FLORIDA, L.L.C.

The undersigned, acting as the sole organizer of COUCH'S PAINTING OF CENTRAL FLORIDA, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

#### ARTICLE I - Name:

The name of the limited liability company is COUCH'S PAINTING OF CENTRAL FLORIDA, L.I..C. (the "Company").

#### ARTICLE II - Address:

The mailing address and street address of the principal office of the limited liability company is 1705 Van Arsdale Street, Oviedo, Florida 32765.

#### ARTICLE III - Duration:

The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of the Operating Agreement of the Company.

#### ARTICLE IV - Management:

The limited liability company is to be managed by a manager, and the name and address of the initial manager who is to serve as sole manager until the first annual meeting of members or until his successor is elected and qualified is:

#### ARTICLE V - Admission of Additional Members:

The Company shall admit new Members only upon the majority written consent of all then existing voting Members of the Company.

ARTICLE VI - Adoption of Operating Agreement:

The Company shall adopt an Operating Agreement for the Company, which Operating may contain any provisions for the regulation and management of the affairs of the Articles of Organization, or Chapter 608, Fla. Stat. Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization, or Chapter 608, Fla. Stat.

## ARTICLE VII - Initial Registered Agent and Office:

The initial registered agent for the Company shall be Marvin Ray Couch, and the street address of the Company's registered agent is 1705 Van Arsdale Street, Oviedo, Florida 32765. A copy of the registered agent's acceptance to serve accompanies these Articles.

### ARTICLE VIII - Amendments:

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the majority written approval of all voting Members of the Company.

#### ARTICLE IX - Indemnification:

Each individual or entity who is or was a manager of the Company (and the heirs, executor, personal representatives, administrators, successors or assigns of such individual or entity) who was or is made a party to, or is involved in any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that such person is or was a manager of the Company ("Indemnitee"), shall be indemnified and held harmless by the Company to the fullest extent permitted by applicable law, as the same exists or may hereafter be amended. In addition to the indemnification conferred in this Article, the Indemnitee shall also be entitled to have paid directly by the Company the expenses reasonably incurred in defending any such proceeding against such Indemnitee in advance of its final disposition, to the fullest extent authorized by applicable law, as the same exists or may hereafter be amended. The rights and authority conferred in this Article shall not be exclusive of any other right which any person may have or hereafter acquire under any statute, provision of the Articles of Organization or Operating Agreement of the Company, agreement, vote of Members or otherwise. Any repeal or amendment of this Article by the Members of the Company shall not adversely affect any right or protection of a manager or officer existing at the time of such repeal or amendment.

#### ARTICLE X – Member Interests:

The Company is authorized to issue both voting and nonvoting units of membership interest. All membership interests shall be identical in all respects except the nonvoting membership interests shall carry no right to vote on any matter except as the State of Florida requires that voting rights be granted nonvoting membership interests.
