**ARTICLES OF ORGANIZATION
OF
PINNACLE ANESTHESIA, PL**

**Organized under § 608.407 of the Florida Limited Liability Company Act
and
§ 621.051 of the Professional Service Corporation and Limited Liability Company Act**

ARTICLE I — NAME

The name of the professional limited liability company is: **PINNACLE ANESTHESIA, PL.**

ARTICLE II — ADDRESS

ARTICLE III — PURPOSE

ARTICLE V — MANAGEMENT BY MEMBERS
