The undersigned, being authorized to execute and file these Articles pursuant to Chapter 608, Florida Statutes, hereby certifies that:

**ARTICLE I — Name**

The name of the Limited Liability Company is O'Carroll Properties, LLC.

**ARTICLE II — Address**




