ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby make acknowledge, and file the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **INFINITY RECORDS, LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 7050 Southwest 107th Street, Pinecrest, Florida 33156 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE


