#### ARTICLES OF ORGANIZATION FOR GENERAL DISTRIBUTORS, LLC

ARTICLE 1 – Name. The name of the limited liability company shall be General Distributore LLC.

ARTICLE 2 - Address of Principal Office. The mailing address and principal office of the limited liability company shall be 7041 Grand National Drive, #120, Orlando, Florida 328 19.

ARTICLE 3 – Registered Office and Registered Agent. The name and the Florid street address of the initial registered agent is Philip K. Calandrino, P.A., 7232 Sand Lake Road, Suite 201, Orlando, Florida 32819.
