**ARTICLES OF ORGANIZATION OF FOR  
MOSKOWITZ AND DENNIS, P.L.L.C**

The undersigned person acting as an organizer of a professional limited liability company under the Florida Limited Liability Company Act, hereby adopts the following articles of organization.

- 1. Name.** The name of this limited liability company is "Moskowitz & Dennis, P.L.L.C."
- 2. Duration.** The period of this limited liability company is perpetual, unless sooner dissolved.
- 3. Purpose.** The sole purpose for which this limited liability company is organized is the practice of law as specifically authorized by Florida law. This limited liability company will not practice law except by and through licensed members or licensed employees, all of whom shall retain their professional licenses in good standing and shall be subject to all rules, regulations, standards and requirements pertaining to their professional legal activities. This company shall not engage in the business of banking or insurance.
- 4. Principal Place of Business.** The address of its principal place of business is: **3111 Stirling Road, Suite C-303, Ft. Lauderdale, Florida 33312.**
- 5. Registered Agent & Office.** The name and address of its registered agent, whose "Consent to Appointment as Registered Agent" is submitted with these articles, is **Larry Moskowitz**. The address of its registered office is: **3111 Stirling Road, Suite C-303, Ft. Lauderdale, Florida 33312.**
- 6. Members.** All members of this company shall be persons duly licensed by the Supreme Court of Florida to practice law in the State of Florida, and who at all times are members of this company in their own right. Members shall be individuals who, except for illness, accident, time spent in the armed services, on vacations and on leaves of absence not to exceed one year, are actively engaged in the practice of law for this company.
- 7. Admission of Additional Members.** Additional members may be admitted only upon such terms as are unanimously agreed to by all members pursuant to provisions in the operating agreement. All members must be licensed attorneys.
- 8. Continuity.** The members of this company have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or occurrence of any other event that terminates the continued membership of a member in this company. Continuation may occur only pursuant to the terms of the operating agreement.
- 9. Withdrawal of a Member.** The withdrawal of a member from this company may occur only on terms agreed on by the parties in the operating agreement and subject to the limitations of the operating agreement. Every member who ceases to be eligible to be a member must forthwith dispose of all their ownership interests by conveying same back to the company.
