ARTICLES OF ORGANIZATION FOR

GUARDIAN SELF STORAGE/DMS, L.C. A Florida Limited Liability Company

The undersigned, desiring to form a limited liability company pursuant to the provisions of the Florida Limited Liability Company Act, hereby submits and files with the Florida Department of State, these Articles of Organization.

ARTICLE I

Name
