
**ARTICLE V**

**ARTICLE VII  
ADMISSION OF NEW MEMBERS**

The admission of new Members shall be solely by unanimous vote (in interest) of the existing members.

**ARTICLE VIII  
DISSOLUTION - WINDING UP - LIQUIDATION**

A. **Dissolution.** Subject to the terms of Subsection B below, the Limited Liability Company shall be dissolved on the happening of any of the following events:

1. Withdrawal (if allowed by the Regulations of the Limited Liability Company), retirement, death, or bankruptcy of any Member.
2. Dissolution of any Member who is an entity.
3. Unanimous written agreement of the Members.

B. **Right to Continue Business.** Notwithstanding Subsection A above, the non-terminated Members ("Remaining Members") of the Limited Liability Company shall have the right to continue the business of the Limited Liability Company, despite the occurrence of any event which terminates the continued membership of a Member in the Limited Liability Company. The exercise of this right to continue shall be by written notice by any one or more of the Remaining Members (representing at least a majority of the interests in the Limited Liability Company) to the other Remaining Members within thirty (30) days of any event described in Subsection A. of this Article. This Subsection B shall not, however, allow for continuation of the Limited Liability Company if the number of Members at any time is less than two (2).






