ARTICLES OF ORGANIZATION OF SUNSET POOL SERVICE, LLC

ARTICLE I Name

The name of the limited liability company ("Company") is SUNSET POOL SERVICE, LLC.

ARTICLE II Address

- Enlarge the ownership interest, rights, privileges, or benefits or reduce the duties and obligations of the Manager[s], or;

- Affect the rights or restrictions regarding the assignability of d. Member ownership interests, or;
 - e. Amend this Article V, or;

- f. Dissolve or terminate the existence of this Company, or;
