ARTICLE I

NAME, PRINCIPAL PLACE OF BUSINESS, MAILING ADDRESS AND DURATION

2. In furtherance of its purposes, the LLC shall have all of the general and specific powers and rights granted to and conferred on an LLC by the Act.


**ARTICLE IV - MEMBER MANAGEMENT RIGHTS


