Articles of Organization of Lake Time, L.C.

The undersigned hereby execute and acknowledge the following Articles of Organization for the purpose of forming a Florida limited liability company under the Florida Limited Liability Company Act (Florida Statutes, Chapter 608).

Article I - Name

The name of the limited liability company is Lake Time, L.C.

Article II - Address

Article III - Duration


Article VIII - Status
