ARTICLE III (DURATION)

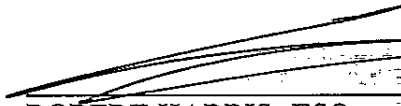

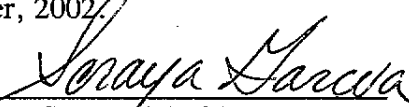
