**ARTICLES OF ORGANIZATION
OF
PINE RUN, LLC**

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be Pine Run, LLC ("Company").

ARTICLE II -- ADDRESS

The street address of the principal office of the Company shall be:

ARTICLE III -- DURATION

The Company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the state of Florida is Kenneth B. Kirkpatrick, 2605 S. W. 33rd Street, Suite 200, Ocala, FL 34474.

ARTICLE V -- MEMBERS

The initial members shall be Kenneth B. Kirkpatrick, James E. Day and Jon M. Kurtz. No additional members shall be admitted to the Company except with the unanimous written consent of all existing members and on such terms and conditions as shall be determined by all existing members. A member may transfer any interest he or she has in the Company but the other members shall have a right of first refusal to purchase that interest. If no member purchases pursuant to the right of first refusal, the transferring member may sell to anyone but only at a price that equals or exceeds the price at which the transferring member offered to sell to other members.

ARTICLE VI – TERMINATION OF EXISTENCE

The Company shall be dissolved on the occurrence of event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there is at least one remaining member.

ARTICLE VII –MANAGEMENT

The Company is be managed by one or more members and is therefore a member-managed company selected as provided in the regulations adopted at the organizational meeting.

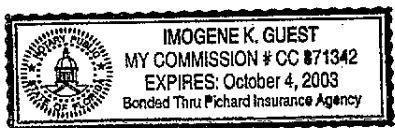

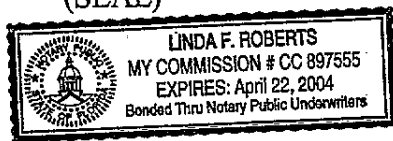
