ARTICLES OF ORGANIZATION

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, sets forth the following:

ARTICLE I - NAME:

The name of the Limited Liability Company is MARKET PLACE PROPERTIES, L.L.C.

ARTICLE II - ADDRESS:

The mailing address is P.O. Box 760 Apalachicola, Florida 32329 and the street address of the principal office of the Limited Liability Company is 18, 7th Street, Apalachicola, Florida 32320.

ARTICLE III - DURATION:

The period of duration for the Limited Liability Company shall commence upon filing of these Articles in the office of the Secretary of State of Florida and shall terminate upon dissolution pursuant to the provisions of the Florida Limited Liability Company Act.

ARTICLE IV - PURPOSE

The purpose for which the Limited Liability Company is organized is to engage in any and all lawful businesses and activities permitted by the laws of the State of Florida. The Limited Liability Company shall have all the powers vested in a Limited Liability Company organized and existing by virtue of such laws, including, but not

limited to, the power to invest in real estate.

#### ARTICLE V - MANAGEMENT:

The Limited Liability Company is to be managed by a managing member. The name and addresses of the initial managing member who will serve as such until his successor is elected and qualifies is as follows:

#### ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

Members may be admitted upon approval of a majority in interest of the members.

#### ARTICLE VII - MEMBERS RIGHTS TO CONTINUE BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company, the business of the Limited Liability Company shall be continued unless the members elect otherwise.

#### ARTICLE VIII - REGISTERED AGENT

The name and address of the initial registered agent in Florida for the Limited Liability Company is LEON R. BLOODWORTH, 18, 7th Street, Apalachicola, Florida 32320.

## ARTICLE IX - CLASSES OF MEMBERS

The Limited Liability Company shall have one class and one series of members.

## ARTICLE X - REGULATIONS

The power to adopt, alter, amend or repeal the Regulations shall be vested in the Members.

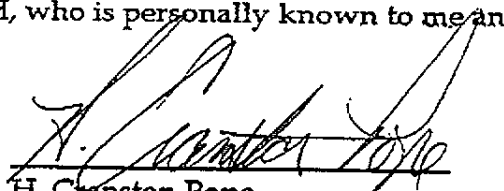
