ARTICLES OF ORGANIZATION OF NORTHSTAR OF JACKSONVILLE, L.L.C.

The undersigned organizer and authorized representative of the members, desiring to form a Limited Liability Company pursuant to Chapter 608 of the laws of the State of Florida, The Florida Limited Liability Company Act, hereby certifies as follows:

ARTICLE 1 - NAME

The name of the company shall be Northstar of Jacksonville, L.L.C.

ARTICLE 2 - PRINCIPAL OFFICE

The address of the principal office of the company is 13171 Atlantic Boulevard, Jacksonville, Florida 32225.

ARTICLE 3 - DURATION

The duration of the company shall be perpetual, unless terminated earlier in accordance with the company's regulations.

ARTICLE 4 - INITIAL REGISTERED AGENT AND ADDRESS

The name and mailing address of the company's registered agent for service of process is William P. Register, 13171 Atlantic Boulevard, Jacksonville, Florida 32225.

ARTICLE 5 - INITIAL MEMBERS

The initial member of the Company shall be William P. Register.

ARTICLE 6 - ADDITIONAL MEMBERS

The members shall be entitled to admit additional members upon the consent of the company's Board of Managers. Following the consent of the Board of Managers, any prospective member shall become a member upon payment of his, her or its

contribution to the capital of the company and upon such prospective member's agreement to comply with the Articles of Organization and Regulations of the company.

ARTICLE 7 - DISSOLUTION OF COMPANY

The death, retirement, resignation, expulsion, bankruptcy or dissolution of a member shall terminate the membership in the company. Upon the occurrence of any such event or any other that terminates the continued membership of a member in the company, the company shall be dissolved unless all of the remaining members consent to continue the existence of the company.

ARTICLE 8 - MANAGERS

The management of the company shall be vested in a Board of Managers, and the sole initial member is William P. Register whose address is 13171 Atlantic Boulevard, Jacksonville, Florida. Mr. Register shall serve until any successor is elected and qualified.

ARTICLE 9 - RETURN OF CAPITAL

No member shall have the right to the return of its contribution to capital except as provided in the company's regulations.

ARTICLE 10 - AMENDMENT OF ARTICLES OF ORGANIZATION

These Articles of Organization may be amended by majority vote of the voting members of the company as provided in Chapter 608, Florida Statutes.


ARTICLE 11 - REGULATIONS
