ARTICLE VIII



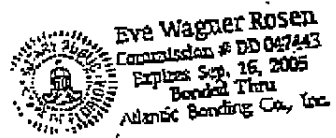
