The name of the limited liability company is "WEST END DEVELOPMENT, L.L.C."

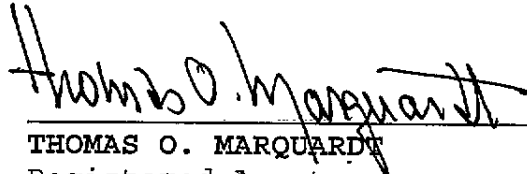
