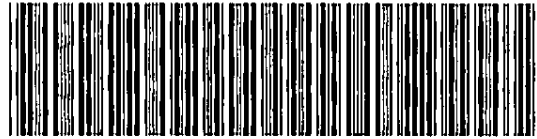



First: The Articles of Organization of ACH ACQUISITIONS, LLC were filed on September 20, 2002, and assigned document number L02000024632.


