#### ARTICLES OF ORGANIZATION

OF

#### TATIANA ENTERPRISES, LLC

The undersigned, for the purpose of forming a limited liability company under the Harida Limited Liability Company Act, Florida Statute Chapter 608, hereby make, acknowledge, and the the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be TATIANA ENTERPRISES, L.

#### ARTICLE II - ADDRESS

#### ARTICLE III - DURATION
