1. **NAME.**

The name of the Limited Liability Company is:

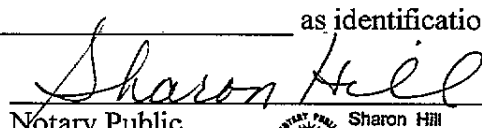
