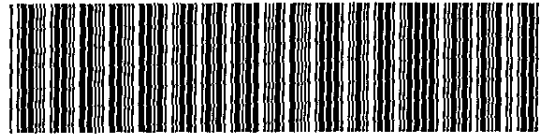


SIXTH: All remaining property and assets by the LLC have been distributed among its members in accordance with their respective rights and interests. There is no remaining property to distribute.

SEVENTH: There are no suits pending against the Company in any court.


EIGHTH: The undersigned are authorized to sign these Articles of Dissolution as a majority of Company interest of the members as set forth in the Operating Agreement.
