ARTICLES OF ORGANIZATION

OF

KEY WEST KEY LIME, LLC,

A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I

NAME

The name of this limited liability company is KEY WEST KEY LIME, LLC, referred to in these Articles of Organization as the "Company."

ARTICLE II

PRINCIPAL OFFICE AND REGISTERED AGENT

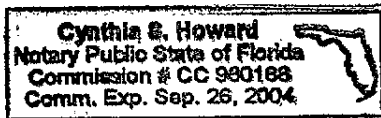
