I hereby file these Articles of Organization as the authorized representative of the members of the limited liability company to be formed pursuant to these Articles of Organization and the laws of the State of Florida.

**ARTICLE I**  
**NAME**

The name of the limited liability company to be formed hereunder is "LONGCASTS LLC" (the "Company").

**ARTICLE II**  
**DATE OF EXISTENCE AND PERIOD OF DURATION**

The Company shall begin existence effective the 23rd day of September, 2002, and shall continue until terminated in accordance with the Regulations and Operating Agreement adopted by the members (the "Operating Agreement").
