# ARTICLES OF ORGANIZATION

OF

N B & R, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

## ARTICLE I - NAME

The name of the limited liability company shall be N B & R, LLC ("Company").

## ARTICLE II - PURPOSE AND POWER
